

TIMBERLAKE COUNTRY CLUB POOL MEMBERSHIP INFORMATION

Timberlake Country Club is once again offering a Summer Pool Only Membership opportunity. Please read before filling out and signing summer pool application.

- ❖ This Pool Membership runs from May 25th until September 2nd (Memorial Day to Labor Day)
- ❖ The Cost is \$425 for a family or individual. The payment is due in full once your membership is approved and is non-refundable
- ❖ A debit or credit card must be kept on file during the membership period of May 25th-September 2nd and will be used to bill for pool guest fees
- ❖ Membership is for the pool ONLY during regular pool hours (this membership does not include any TCC social/golf activities, camps, water aerobics, or TCC member rate for swim team registration)
- ❖ Pool use is only for approved member(s), their children 26 years of age and under that live at home or attend college, and out of town overnight house guests. Any other guest is welcome for a \$5 fee per visit, per guest. Pool member needs to be present with their guest.
- ❖ Approved members will receive wristbands for the amount of family members only. Green pool wristbands should be worn or in view while in the pool area to assist staff in monitoring the use of the pool.

***Please review application, restrictions may apply.

The pool is generally open from 10:00 am until 8:00 pm. TCC reserves the right to alter the times.

If you wish to swim laps prior to 8:00 am, please call the pro-shop (803-345- 9909, extension 14) to make arrangements for early access.

Personal food and beverage (except water) are not permitted in the pool area. Purple Martin Grille and Cellar has food available for purchase and may be brought into the pool area for consumption. Please properly dispose of any trash to ensure the pool area stays clean.

WAIVER AND RELEASE

I further agree that I will indemnify and hold harmless the Timberlake Country Club and their respective officers, directors, employees, and/or staff from any loss, liability, damage or cost of any kind that may incur as the result of any injury to myself, to any member of my family or to any person for whom I am signing this agreement, even if it is contended that any such injury as caused by the negligence or other improper conduct on the part of the Timberlake Country Club and/or their respective officers, directors, employees, and/or staff. I have read and understood the foregoing acknowledgement of risks and agreement not to sue and am voluntarily signing below, intending to be legally bound thereby.

This is an application for membership to the pool facilities of the Timberlake Country Club (hereinafter "Club") for the Summer of 2019 only. Upon acceptance of this Application by the Club, the Applicant agrees to pay the fees stated herein and be bound by all rules and regulations of the Club. Applicant acknowledges that this Membership may not be cancelled or transferred and that the swimming privileges granted to him/her and his/her family under this Membership cannot be transferred. The Club reserves the right to cancel any Membership at any time for cause.

The Club reserves the right to close the pool due to inclement weather, prescheduled special events, or maintenance. The Club shall provide advance notice of such closures whenever possible. Based on weather and other considerations, the Club's facilities will open/close at the discretion of the TCC Staff.

This special pool membership is not available to current TCC members or former members who ended their affiliation with TCC less than one year ago; or former members who left TCC owing a balance/write-off. All applications will be reviewed by the Membership Committee, and if approved a credit card payment will be due in advance and will be non-refundable. The credit card information will be kept on file should any damage occur to TCC property. I understand this application is subject to approval and acknowledge that, in the event it is declined, TCC, Inc. is not obliged to justify its decision.
